#### **EDUCATION UPDATE**

The Alberta Ready-Mixed Concrete Association's courses have wrapped up for the construction season. It was a very productive, busy and successful year for the Alberta Ready-Mixed Concrete Association's educational programs. Educating the people that work for you will give them the tools to not only perform their job better but will enable them to be better employees who can succeed in a dynamic environment.

Through November to April there have been five Concrete Technology Level 1 courses, three Concrete Technology Level 2 courses, three ACI Concrete Field Testing Technician Grade 1 certification programs, one ACI Flatwork course, and one Dispatch Training course. #### **HOT WEATHER CONCRETE**

The hot weather concrete season is upon us, and all of the challenges that go along with pouring concrete in the summer months are just around the corner. Let's take a minute to remember all of the best practices that we can put into place to ensure that all of our hot weather pours are successful.

- Keep a good handle on the temperatures and moistures of all of your concreting materials.
  - Make use of sprinklers on your aggregate piles to work with Mother Nature's natural cooling powers of evaporation.
  - Run daily moistures on your sands even to validate your probe readings to make sure you don't send any thirsty loads out the gate.
- Make appropriate modifications to concrete mix designs to manage rate of slump loss, setting time and other characteristics like bleeding.
  - Retarders, normal, mid and high range water reducers, extended set control admixtures, fly ash, slag, meta-kaolin or other proven local solutions may be used.
  - Reduced cement content while ensuring concrete strength will be attained may be appropriate. Synthetic
     Fibres may be used to reduce the likelihood of plastic shrinkage cracking.
- Have adequate manpower to place, finish and cure the concrete.
  - Schedule the rate of concrete delivery that can be managed by available crew and placement equipment.
- Limit the addition of water at the job site <u>do not</u> exceed the quantity of mixing water established in the mix design.
  - CSA allows water to be added to the load <u>once</u> and only within an hour of the initial batch time stamped on the delivery ticket.
  - Upon addition of water, the mixer drum should be turned a minimum of 30 revolutions at full mixing speed to ensure thorough distribution throughout the load.
- Slabs on grade placed on vapor barriers will need special precautions to when finishing and curing to avoid cracking.
- On dry, hot windy days, when conditions are conducive for plastic shrinkage cracking, dampen the subgrade, forms and reinforcement prior to placing the concrete.
  - Do not allow excess water to pond.
- Make use of evaporation retarders behind screeding operations and before floating or trowelling.
- Begin final finishing operations as soon as the bleed water sheen has left the surface; start curing as soon is finishing is completed.
  - Continue curing for at least 3 days at a minimum temperature of 10°C. Wet cure the concrete by continuous ponding or by covering the concrete with wet burlap or an un-woven geotextile and plastic sheeting to prevent evaporation.
  - Or, use a liquid membrane curing compound. Using white pigmented membrane curing compounds will help to ensure proper coverage and will help reflect heat from the concrete surface.
- Protect concrete test cylinders on the jobsite to maintain temperature and moisture for the initial curing period.
  - Field curing boxes with ice or refrigeration may be necessary to ensure that the temperature immediately around test cylinders is kept at  $20 + -5^{\circ}$  C for the first 28 + 8 hours.
  - A maximum/ minimum thermometer must be used to validate initial cure temperature compliance with this CSA test standard.
- Accelerators may be used in hot weather to expedite finishing operations and to avoid plastic shrinkage cracking.
  - An appropriate <u>sized</u> and <u>experienced</u> placing and finishing crew is vital when this approach is taken.

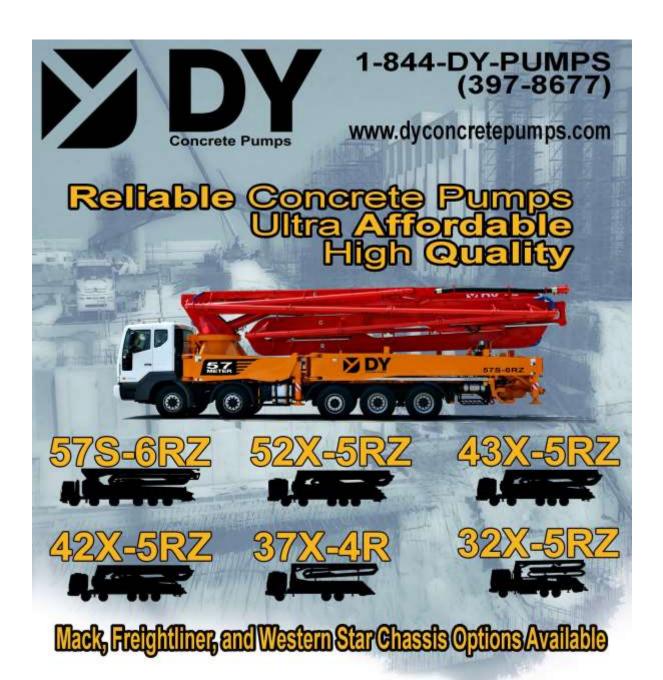

#### ARMCA has a new Safety Committee!

About a year ago we were so busy some of us were going 200 km/hr with our hair on fire! It seemed you'd read about at least one construction fatality a month in the oil or construction industry; and to me this says a couple things. Some have become so busy that they have their sights set on getting the job done quickly, at the cost of adhering to established safety programs. The other factor may be fatigue, as we try to extract extra minutes or even hours out of our daily lives to just get one more thing accomplished whether it be business related or personal.

It's nice to hear that, for the most part, everyone is still staying fairly busy this year but we need to make sure that we learn how to bring safety back where it belongs, in all aspects of our lives. The new ARMCA Safety Committee hopes to give everyone that opportunity by developing and promoting the tools and resources that can be used to reinforce the practices that can be taken to ensure safety forms an integral part of the work environment.

#### **WHMIS 2015**

Alberta Occupational Health and Safety regulations require employers to provide training of employees on how to safely work with any potentially harmful chemicals or materials in the workplace. In 1988, under the Hazardous Products Act and Controlled Products Regulations, the Workplace Hazardous Materials Information System (WHMIS) was established, including the use of Material Safety Data Sheets (MSDS).

An MSDS is required for any potentially harmful or hazardous chemicals or materials used by an employee. These must be available for employees to review at any time, and list information on the physical and chemical makeup of workplace materials. The MSDS lists first aid information for use if an employee is improperly exposed to the product. It also lists what effect the substance will have on the environment if released and what steps can be taken.

As of 2015," The Hazardous Products Act (HPA) has been amended, and the WHMIS requirements for hazard classification and communication set out in the Controlled Product Regulations (CPR) and the Ingredient Disclosure List repealed and replaced with new regulations, the Hazardous Products Regulations (HPR). This modified WHMIS is referred to as WHMIS 2015. The Hazardous Products Act and Hazardous Products Regulations regulate suppliers of hazardous products (defined as persons who, in the course of business, sell or import a hazardous product) while federal, provincial and territorial (FPT) occupational health and safety (OHS) authorities regulate the employer requirements of WHMIS in workplaces.

To fully implement **WHMIS 2015**, changes to the federal, provincial and territorial occupational health and safety requirements for hazard communication devices, specifically labels and safety data sheets, are required. This new system will incorporate the Globally Harmonized System of Classification and Labelling of Chemicals (GHS). The Globally Harmonized System requires the use of a standardized 16-section Safety Data Sheets with minimum information requirements for each section. The Safety Data Sheets must provide the Globally Harmonized System hazard classification for the product, the Globally Harmonized System label text, and information on any other hazards. The Globally Harmonized System label text consists of standardized pictograms, signal words, hazard

statements. Additionally, products are subject to additional regulation by Environment Canada, provincial environment ministries or other regulatory agencies, if they are used or stored in larger quantities.

To give suppliers, employers and workers time to adjust to the new system, implementation of the Globally Harmonized System of Classification and Labelling of Chemicals (GHS) (WHMIS 2015) will take place over a three-stage transition period that is synchronized nationally across federal, provincial and territorial jurisdictions.
